ELECTRA PARTNERS SELLS STAKE IN ZENSAR TECHNOLOGIES

DEAL BRIEF

Electra Partners Mauritius Limited, a subsidiary of Electra Private Equity Plc ("**Electra Plc**") recently agreed to sell its 23.23% stake in Zensar Technologies Limited ("**Zensar**"), an Indian listed company to Marina Holdco (FPI) Limited, a company backed by funds advised by Apax Partners LLP ("**Apax**") for a consideration of approximately USD 130 million.

Established in 1963, Zensar is a Pune based information technology services and infrastructure services provider with operations and a customer base spanning 29 global locations. Zensar is also a market leader in powering next-generation enterprises with its cloud, mobility and social media solutions.
